MDIS COLLEGE Terms and Conditions of Offer

When you commence your programme with MDIS College, you are deemed to have read, understood and accepted our offer for the same upon the terms and conditions set out hereinafter.

Subject to any other terms and conditions contained in the MDIS College Confirmation Letter to you, MDIS College Terms and Conditions of Offer are as follows:

1. Withdrawal Without Cause and Refunds

a. Registration fees paid to MDIS College are non-refundable. Only the paid course fees are refundable on the following conditions:

Percentage of refund before the course commencement date

Percentage of refund for paid 1st instalment of course fees	If Student's written notice of withdrawal is received
100%	More than 60 days before the commencement date
75%	Between 30 to 60 days before the commencement date
25%	Less than 30 days to 1 day before the commencement date

Percentage of refund after the course commencement date

Percentage of refund for paid course fees	If Student's written notice of withdrawal is received
10% of the first instalment fees + 100% of other instalments paid if any	First day to 14th day after the commencement date
No refund. In addition, the students are required to pay 80% of the total course fee	14 days after the commencement date but before completing 50% of the programme/course/module
Students are liable to pay full course fees, immediately upon approval of withdrawal	Withdrawal after completion of half of the duration of the programme / course or 50% completion of the modules of the programme whichever is earlier

- b. Request for programme withdrawal must be made in writing. The student should write in to the Senior Manager of MDIS College to request for withdrawal from the programme. All requests must be supported with documentary evidence. Withdrawal through the telephone will not be entertained.
- c. In the event that a company-sponsored student withdraws, the company is liable to pay any outstanding course fees.
- d. Full refund will be given in the event of non-approval of National Service deferment before course commencement and a pro-rated refund shall be given after course commencement.
- e. In the event where a student is applying for a study loan, the registration fees where applicable must be paid PRIOR to the application of the loan.
- f. An administrative fee of S\$100 (subject to prevailing GST) will be levied on each late instalment payment.
- g. The discretion of approving a refund of fees outside the tabulated conditions under Refund Policy lies with the College. The decision of the College is final.
- h. All approved refunds shall be made within fourteen (14) days from the date of letter of approval sent to the student.

2. Deferment Policy

- a. Deferment of subject is allowed only ONCE up to the next available commencement date of the course. Deferment of course is allowed only ONCE up to a MAXIMUM PERIOD OF ONE (1) YEAR, failing which the applicant will be deemed as having withdrawn from the course.
- b. All requests for deferment PRIOR to or AFTER commencement of programme must be made in writing to the Senior Manager of MDIS College. Deferment through the telephone will not be entertained. All requests must be supported with documentary evidence.
- c. There will be no refund of course fees paid in the event of DEFERMENT regardless of whether the request is made PRIOR TO or AFTER the commencement of the programme.
- d. Approval for deferment is at the sole discretion of the College. The decision of the College is final.

3. Transfer Policy

- a. Student who requests for a change of programme within MDIS will be considered as breaking the agreement. A transfer application fee of S\$500 (subject to prevailing GST) is applicable. All requests for transfer must be submitted in writing to the Senior Manager of MDIS College.
- b. The student will be charged for all lessons consumed and all the transfer requests must be submitted before or within one (1) month from the commencement of class. All discounts / rebates that the student was entitled to shall be forfeited.
- c. Transfer requests after one (1) month from the class commencement date will not be entertained. Students who insist on a transfer will have their request processed as a withdrawal and the withdrawal policy shall apply.
- d. In the event that a student has paid in excess of consumed fees, the College will process the refund of the unconsumed fee portion accordingly.
